

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF NOVENA, INC.

DIVISION OF CORPORATI

NOVENA, INC., a Florida corporation (the "Corporation"), hereby certified as follows:

1. The Articles of Incorporation of the Corporation are hereby amended by deleting the present form of Article IV in its entirety and by substituting, in lieu thereof, the following:

"ARTICLE IV

Capital Stock

The number of shares of capital stock which the corporation is authorized to issue is 60,000,000 shares, designated as follows: (a) 50,000,000 shares of Common Stock having a par value of \$0.01 per share, and (b) 30,000,000 shares of Preferred Stock having a par value of \$0.01 per share, which shall be designated "Preferred Stock," to be issued in such series with such designations, rights, privileges and preferences, dividends, splits, conversions or other issues as shall be determined from time to time by the Board of Directors of the Corporation."

- 2. The foregoing amendment shall become effective as of the close of business on the date these Articles of Amendment are approved by the Florida Department of State and all filing fees then due have been paid, all in accordance with the corporation laws of the State of Florida.
- 3. The amendment recited in Section 1 above has been duly adopted in accordance with Florida Statutes, by the Board of Directors of the Corporation who adopted a resolution setting forth such amendment and declaring its advisability and directing that such amendment be considered by the Shareholders of the Corporation; and by a majority in interest of the Corporation's common voting stock having voted in favor thereof by written action dated March 7, 2003, which said votes cast for the amendment were sufficient for approval.
