**ARTICLES OF INCORPORATION  
OF  
SKELDING PROPERTIES, INC.**

**A FLORIDA FOR PROFIT CORPORATION**

The undersigned, desiring to form a for profit corporation in accordance with Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation:

**ARTICLE I**

**Name and Principal Place of Business**

The name of the Corporation is SKELDING PROPERTIES, INC. The Corporation's initial principal place of business shall be 318 North Monroe Street, Tallahassee, FL 32301.

**ARTICLE II**

**Purpose**

The purpose for which the corporation is organized shall be to engage in and carry on all lawful business.

**ARTICLE III**

**Duration**

The term of existence of the Corporation is perpetual; and the corporate existence will commence on the filing of these Articles of Incorporation with the Department of State.

**ARTICLE IV**

**Registered Office**

### **Amendment of Articles**

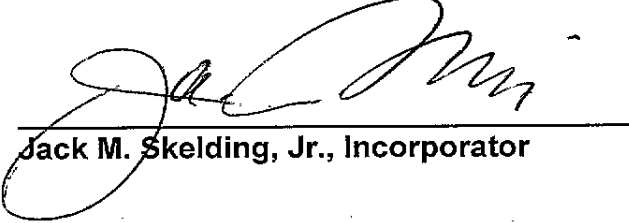

## ARTICLE X

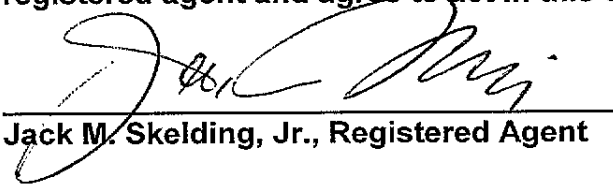
### Indemnification
