
## ARTICLE V - AUTHORIZED SHARES

The undersigned incorporator, for the purpose of forming a corporation under the laws of the State of Florida, has executed these articles of incorporation this 16th day of April 2002.



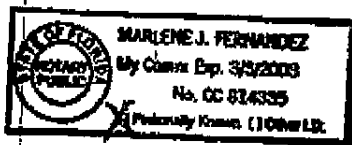
