ARTICLES OF INCORPORATION

The undersigned, being a natural person and a duly licensed real estate sales agent under the laws of the State of Florida, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a Professional Service Corporation pursuant to the provisions of the Professional Service Corporation Act (Section 621, Florida Statutes), and the Florida General Corporation Act (Section 607, Florida Statutes).

FIRST: The name of the corporation (hereinafter called the "Corporation") is Michael Bergman, P.A.

SECOND: The principal office or mailing address of the Corporation is: 12346 NW 52nd Court, Coral Springs, FL 33076

THIRD: The duration of the Corporation shall be perpetual.

FOURTH: The aggregate number of shares of stock that the Corporation is authorized to have outstanding at any one time is one thousand (1000), all of which shall have a par value of one cent (\$.01) each and are of the same class and are to be common shares.

FIFTH: The purposes for which the corporation is organized are as follows:

(a) To engage in every phase and aspect of real estate sales.

(b) To do everything necessary and proper in accomplishing the purposes set forth in this Article and to have the full power and authority of a Professional Service Corporation as provided in the laws of the State of Florida.

In the event these Articles are not received within such five (5) day period, then the corporation's corporate existence shall commence upon the filing of these Articles of Incorporation by the Department of State, State of Florida.
