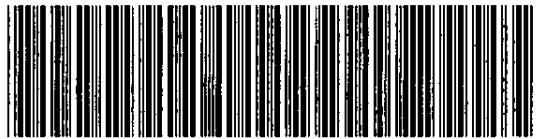

Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned, J.J. Dahl, President and Secretary of Law Office of J.J. Dahl, P.A. (the "Corporation"), for and on behalf of the Corporation, upon approval of the sole director, and approval by the sole shareholder entitled to vote hereby adopts the following amendments to its Articles of Incorporation:

1. The name of the Corporation is Law Office of J.J. Dahl, P.A., whose document number is P02000041653.
2. Article I is deleted in its entirety and the following is inserted in its place:

**Article I. Name**

The name of this corporation is **Dahl Family Law Group, Inc.** The Corporation is being formed for the practice of law and all other activities permitted under applicable law.

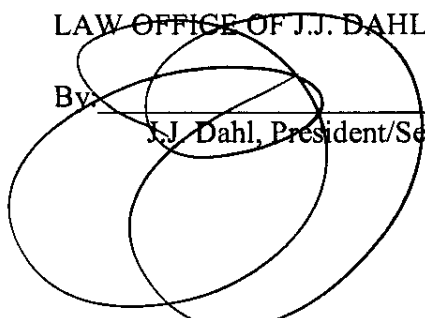
4. The effective date of these First Articles of Amendment to the Articles of Incorporation shall be upon the filing thereof with the Florida Department of State, Division of Corporations.
