## ARTICLES OF INCORPORATION

# YACHTLIZARD, INC.

Acting as Incorporator of a corporation under the Florida General Corporation Act, the undersigned adopts the following Articles of Incorporation for such Corporation.

The name of the corporation shall be: YACHTLIZARD, INC.

The period of duration for the Corporation is to be perpetual.

The purpose or purposes for which the Corporation is organized is to engage in and conduct any and all business activities permitted under the laws of the United States and of the State of Florida.

The aggregate number of shares which the Corporation is authorized to issue is FTVE HUNDRED (500). Such shares shall be of Common Stock having a par value of ONE AND NO/100 (1.00) DOLLAR per share.

The holders of the outstanding capital stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable in cash, property, or in shares of the not issued capital stock of the Corporation. The Common Shares of the Corporation are not to be divided into classes.

Shares held by the initial Shareholders may not be sold or otherwise transferred to another person unless first offered to the remaining shareholders, or to this Corporation, the price and terms which, at the time within which those shares may be offered and sold, shall be further specified as the price at which such shares are offered to others.

The current shareholders shall have pre-emtive rights to purchase at prices, terms, and conditions, which shall be fixed by the Board of Directors, such of the stock of this Corporation as may be used for money, or any property or service, from time to time, in addition to that stock authorized and issued by the Corporation.
