

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607, F.S., adopts the following articles of incorporation:

ARTICLE ONE
NAME

The name of the corporation is **MARY BORGAN COMMERCIAL, INC.**

ARTICLE TWO
PRINCIPAL OFFICE

The street address and mailing address of the initial principal office of the corporation is 7512 Dr. Phillips Boulevard, Suite 50, PMB 286, Orlando, Florida 32819.

ARTICLE THREE
CORPORATE DURATION

The duration of the corporation is perpetual. Corporate existence shall commence at the date and time of the filing of the articles of incorporation with the Department of State.

ARTICLE FOUR
PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

1. To engage in the business of marketing for interior decor, including but not limited to millwork, upholstery, carpeting, wallpaper, window treatments, bedding and furniture, and
2. To transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the preceding business, and
3. To do such other things as are incidental to the above or necessary or desirable in order to accomplish the above.

ARTICLE FIVE CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is ten thousand (10,000). Such shares shall be of a single class, and shall have a par value of one (\$0.10) dollar per share. No preemptive rights are to be granted to shareholders.

ARTICLE SIX REGISTERED OFFICE AND AGENT


