#### ARTICLES OF INCORPORATION OF:

# STORIA MARBLE & GRANITE, INC.

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE I - NAME

The name of this corporation is STORIA MARBLE & GRANITE, INC. (Hereinafter, "Corporation").

#### ARTICLE VII AMENDMENT

These articles of Incorporation may be amended in the manner provided by law.
