**ARTICLE ONE**

The name of this corporation is WIZARD TECHNOLOGIES GROUP, INC. and the mailing address of the corporation shall be 411 NE 24<sup>th</sup> Place, Cape Coral, FL 33909.

**ARTICLE TWO**

The date of the commencement of corporate existence of the corporation shall be the date these Articles are filed with the Secretary of State.


## **ARTICLE NINE**



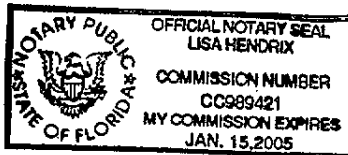


