Your letter dated September 11 is causing me great consternation and this letter is to clarify our position allowing you to correct the UBR status of Play and Shade Inc.

Initially, please find enclosed my letters to you of June 23 and September 9, respectively.


Whilst both letters are, I believe, self-explanatory, I would add that on receipt of the three 'new' September 2003 UBR's we were indeed puzzled as to why we had gotten three when only one was needed since two of the companies were to be voluntary dissolved.

Nonetheless all three were filed for later execution and it was only when this action was necessary that we saw for the first time what was being called for.

Realizing our mistake in our April filings and what we believe is your mistake, too, we sent you our explanatory letter of September 9.

I ask you, thus, to please file the UBR for Play and Shade Inc and send us voluntary dissolution forms for the other two companies for us to complete which is, what I assume, must now happen.

On April 25 I sent you the following documents:

1. A check for \$70 as fees for the voluntary dissolution of Cornucopia Enterprises Inc. and Play and Shade Inc along with the completed forms, as required.
2. A check for \$150.00 for the UBR for 2003 for Southern Development Network Inc and the completed UBR form.

Because my May bank statement did not reflect payment of these two checks and concerned as to why this should be, I called your office on 6.3.03 and was informed by an Amy that there was no record of my checks or documents but that since your office was experiencing a hold up in processing, I should wait another week or so to allay my concern. Alternatively, she said that, perhaps, my stuff had got lost in the mail.
