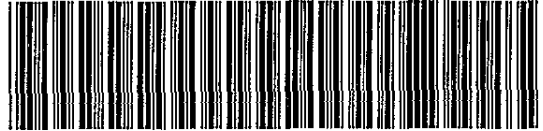

TO THE ARTICLES OF INCORPORATION OF
ANEXIO, INC.**

The undersigned, Jeffrey Nelson, President of ANEXIO, INC., does hereby certify that:

1. He is the President of ANEXIO, INC. a Florida corporation, which Articles of Incorporation were filed with the Secretary of State of Florida, on April 18, 2002.
2. On January 1, 2003, the Board of Directors passed a resolution changing the name from ANEXIO, INC. to SENTINEL ALLIANCE, INC. This amendment for name change became effective on, January 1, 2003.
3. The following amendment to the Articles of Incorporation was unanimously adopted by the Board of Directors and approved by the Shareholders, at a special meeting at which all of the Directors and Shareholders were present and voting throughout, duly called for the purpose of adopting this Amendment and held on January 1, 2003.

Article I of the Articles of Incorporation is hereby deleted in its entirety and amended to read as follows:

"ARTICLE I - NAME

The name of this Corporation shall be amended from ANEXIO, INC. to SENTINEL ALLIANCE, INC. and shall now be known as SENTINEL ALLIANCE, INC."
