Attached please find a copy of the cancelled check sent in and deposited by the State of Florida for the report due by or before May 1st, 2004. We never received any notice by mail or otherwise about being administratively dissolved and only discovered same this date.

There are extenuating circumstances in this matter and we respectfully ask that the original amount mailed to you in April 2004 for the 2004 For Profit Corporation Annual Report (AR). We have also enclosed an additional check for \$150.00 to pre-pay the 2005 For Profit Corporation Annual Report (AR).

(1) Our former bookkeeper/tax preparer Fran's Tax Service received our mail without our knowledge in 2003 and 2004, and then went out of business under duress by their clients and lawsuits without giving us our mail. The old mail address of P O Box 734, Callahan, FL 32011-0734 was her address, not ours.

(2) In 2004 we went to a CPA in Folkston, GA to handle our taxes and this renewal for 2004. He also took our money, but obviously did not know he could not legitimately serve as our Registered Agent (his residence and office is in Georgia). He will not deal responsibly with this matter.

(3) *We never received notices of the dissolution nor did we receive correspondence from your office about the error regarding the "new" Registered Agent living and working in Georgia.*

Please grant my request and accept the first check for \$150 for 2004 For Profit Corporation Annual Report (AR), reinstate the corporation, and then accept the additional check for \$150.00 to prepay the 2005 For Profit Corporation Annual Report. We will file the form itself if your department will advise us to do so at the legitimate address shown on the enclosed document. Please do waive any and all penalties in this matter.
