OF

The date of commencement of corporate existence shall be upon filing and the Corporation shall have perpetual existence.

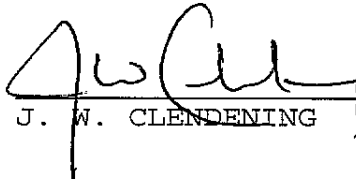
Article VI - Initial Board of Directors

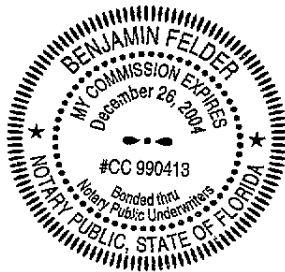
