# ARTICLE I Name of Corporation

The name of this corporation is THOMAS W. MESKO, M.D., P.A.

### ARTICLE II Corporate Existence

This corporation shall have perpetual existence.

# ARTICLE III Purpose of Business

The purpose of this corporation is to engage in the practice of medicine and the transaction of any and all business related thereto as permitted under the laws of the United States and of this state.

# ARTICLE IV Principal Place of Business

The address of the principal place of business of this corporation is 4300 Alton Road, 2nd Floor, Miami Beach, FL 33140.

# ARTICLE V Registered Office

The address of the initial registered office of the corporation is c/o Jeffrey S. The Board of Directors may from time to time move the registered office to any other address in Florida.

#### ARTICLE VI Registered Agent

Any director of this corporation may vote upon any contract or other transaction between the corporation and any subsidiary or controlled company without regard to the fact that he is also a director of such subsidiary or controlled company.

#### ARTICLE XI <u>Amendment</u>

These Articles of Incorporation may be amended, changed, altered, or repealed only by majority vote of the outstanding common shares.
