



CERTIFICATE OF INCORPORATION

FOR

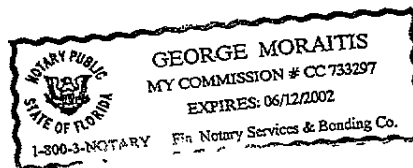


