

### ARTICLES OF INCORPORATION OF PROFESSIONAL BODYWORK, INC.

THE UNDERSIGNED HEREBY MAKES, SUBSCRIBES, ACKNOWLEDGES AND FILES THE FOLLOWING ARTICLES OF INCORPORATION:

### ARTICLE I

THE NAME OF THIS CORPORATION SHALL BE:
