CERTIFICATE OF INCORPORATION

OF

alter or abolish such reserve.





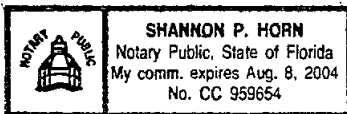
