The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE I. NAME AND ADDRESS: The name and address of the corporation is: SOUTHERN COMFORT CUSTOM HOMES and PLUMBING CONSTRUCTION, INC., 48 Emerson Drive, Palm Coast, FL 32164.

ARTICLE II. TERM OF EXISTENCE: The period of its duration is perpetual.

A majority of the outstanding shares of the corporation entitled to vote, represented in person, or by proxy, shall constitute a quorum at any meeting of the shareholders for the management of the business of the corporation.
