## ARTICLES OF INCORPORATION OF

#### ARTICLE I

The name of this Corporation shall be: Bernard, Lee & Edwards Securities, Inc.

#### ARTICLE II

The principal place of business and mailing address of this Corporation shall be: 1016 Shore Acres Drive - Leesburg, Florida 34748
