John Bobek undersigned, being of the age of eighteen (18) years or more, does hereby make and acknowledge these Articles of Incorporation under and by virtue of the laws of the State of Florida

1. The name of the Corporation is Bobek Building Systems, Inc.

2. The number of shares the corporation is authorized to issue shall be 100 shares all of one class designated as common stock.

3. The street address and county of the initial registered office of the corporation is 1980 No. Cameron Avenue, Sanford, Florida

4. The number of directors constituting the initial board of directors shall be one; and the names and addresses of the persons who are to serve as directors until the first meeting of shareholders or until their successors are elected and qualify are

6. The corporation elects to have pre-emptive rights.

7. All shareholders of the corporation are entitled to accumulate their votes for directors. No amendment shall be made to this Article when the number of shares voting against the proposal to amend would be sufficient to elect a director by cumulative voting and such shares are entitled to be voted cumulatively for the election of directors.
