The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

## **ARTICLE I - NAME OF CORPORATION**

The name of this corporation shall be LEO LEGG INDUSTRIAL SERVICES, INC.

#### **ARTICLE II - DURATION**

This corporation shall exist perpetually.

#### **ARTICLE III - INITIAL PRINCIPAL OFFICE**

#### **ARTICLE IV - PURPOSE**
