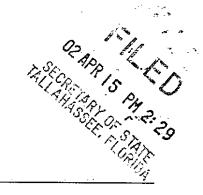

ARTICLES OF INCORPORATION

OF

The undersigned incorporator, desiring to form a professional corporation in accordance with the applicable provisions of Florida law, does hereby adopt the following Articles of Incorporation.

ARTICLE ONE

NAME

The name of the corporation shall be:

LINDER MACHINERY, INC.

ARTICLE TWO

PURPOSES

The purposes for which the Corporation is organized are as follows:

(1) To engage in such other business as may be authorized or permitted under Florida law.

ARTICLE THREE
