ARTICLES OF INCORPORATION
OF
AUCTION ROW INC.

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is Auction Row Inc. and its principal office and mailing address is 3845 SW 111th Way, Davie, FL 33328.

Commencement of Corporate Existence

The corporation shall come into existence on the date of filing with the Florida Secretary of State.

General Nature of Business

Capital Stock

By-Laws




