The undersigned, incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

<u>ARTICLES I: NAME OF THE CORPORATION</u>

The name of the corporation is **WIND ENERGY**, **INC**., hereinafter referred to as the "Corporation".
