Articles of Incorporation

In compliance with Chapter 607 and 621 of the Florida Statutes:

Article I

The name of the corporation shall be WWFF Web Designs, Inc.

Article II

The principal place of business and its mailing address is 2563 Stony Brook Lane,
Clearwater, Florida, 33761.

Article III

WWFF Web Designs, Inc. is organized for the purpose of developing and hosting
web sites on the World Wide Web as well as for any other lawful business purpose
allowed under the rules, regulations, and statutes of the State of Florida.

Article IV

The initial number of shares of stock the corporation is authorized to issue is 1,000
at no par value. No preemptive rights are granted to shareholders other than the right to
vote as set forth in the corporate bi-laws.

Article V

The corporation's Registered Agent is Daniel Gemal, 2563 Stony Brook Lane,
Clearwater, Florida, 33761.

Article VI

The corporation's incorporator is Daniel Gemal, 2563 Stony Brook Lane,

Article VII

The corporate officers and the Board of Directors shall be elected pursuant to the Bi-Laws of the corporation within 30 days of the State of Florida's acceptance of the corporation's Articles of Incorporation. Until that time, the incorporator named herein shall have full power to act on behalf and for the benefit of WWFF Web Designs, Inc.

Article VIII

No shareholder shall be responsible for the debts or liabilities of the corporation solely by virtue of their ownership of stock.

Article IX

The Articles of Incorporation shall become effective upon the date endorsed by the Incorporator and the Registered Agent as evidenced by their respective signatures herein below or five business days prior to the date the Articles of Incorporation are received by the Department of State, Division of Corporations, 409 East Gaines Street, Tallahassee, Florida, 32399, whichever is later.
