**ARTICLE I
CORPORATE NAME**

BOARD OF DIRECTORS



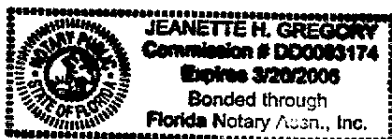
