ARTICLE I - NAME

The name of the Corporation is: CENTRAL FLORIDA PRECAST, INC.

ARTICLE II - DURATION

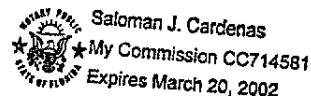
