ARTICLES OF INCORPORATION

OF

TARROB WEB SERVICES, INC.

ARTICLE I - NAME

The name of the corporation is TARROB WEB SERVICES, INC.

ARTICLE II - DURATION

As provided in Florida Statutes, Chapter 607, this corporation shall exist in perpetuity.

ARTICLE III - PURPOSE

ARTICLE XIII - COMMENCEMENT OF EXISTENCE


