The name of the corporation is Video Treasures, Inc.

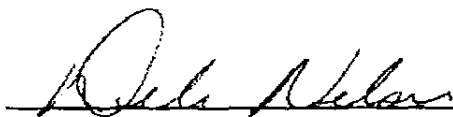
SECOND:

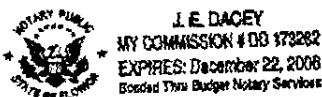

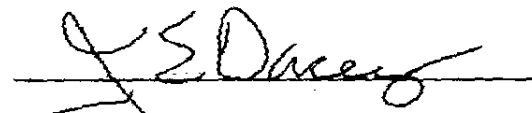
