ARTICLE I - NAME

ARTICLE II - DURATION

The Corporation shall have perpetual existence.

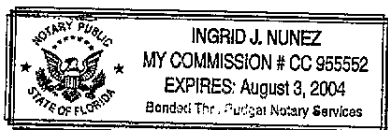
