**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation shall be:
H & E Marine Construction, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on 04-08-02

ARTICLE III - PURPOSE


