I, the undersigned - the incorporator, being a natural person of the age of eighteen years of age or older is hereby signing below for the purpose of forming a corporation under the Florida Department of State, Division of Corporations and to adopt the following Articles of Incorporation:

2. To generate marketing plan(s) that will include advertisement and promotional activities for businesses.
3. To acquire by purchase, lease or otherwise equipment or lands and interests in equipment or lands, and to own, hold, improve, develop, and manage any real estate so acquired, and to erect, or cause to be erected, on any lands owned, held, or occupied by the corporation, buildings, or other structures, with their appurtenances, and to manage, operate, lease, rebuild, enlarge, alter, or improve any buildings or other structures, now or hereafter erected on any lands so owned, held, or occupied, and to encumber or dispose of any equipment or lands or other structures at any time owned or held by the corporation.
4. To acquire, by purchase, lease, manufacture, or otherwise any personal property deemed necessary or useful in the equipment, furnishing, improvement, development, or management of any property, real or personal

at any time owned held, or occupied by the corporation and to invest, trade, and deal in any personal property deemed beneficial to the corporation, and to encumber or dispose of any personal property at any time owned or held by the corporation.

5. To borrow money, to execute promissory notes and to secure loans to the corporation by mortgage, deed of trust, pledge or otherwise, and to assume encumbrances, deeds of trust, or mortgages in connection with the acquisition or purchase of improved or unimproved real estate.
