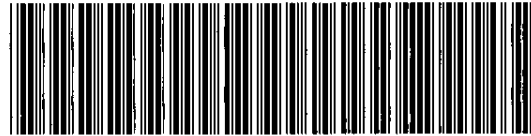

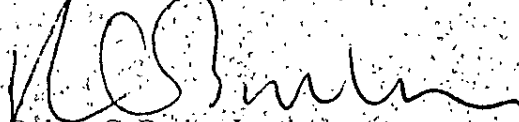

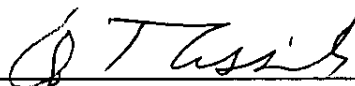
ARTICLE ONE - NAME
