ARTICLES OF INCORPORATION OF A & Z PARKING SERVICES, INC.

ARTICLE ONE

The name of the corporation is A & Z Parking Services, Inc. and its principal office is at 2350-N 34th Street North, St. Petersburg, Florida 33713

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is to engage in the vehicle parking and related business and to perform any services or business incidental thereto.
