The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be Robinson Development Corporation.

ARTICLE II- PRINCIPAL OFFICE
