**ARTICLE FOUR**

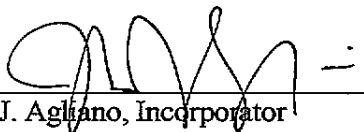
**INITIAL REGISTERED OFFICE AND REGISTERED AGENT**

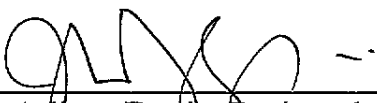
