NAME: The name of the corporation is S & N ELECTRIC, INC

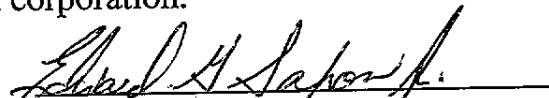
