ARTICLES OF INCORPORATION OF LAW OFFICES OF STEPHEN J. FINTA, P.A.

SEGGENAL PH 1:54 The undersigned, acting as a subscriber of a corporation under the Florida Gener Corporations Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I-NAME AND ADDRESS
