**AMENDMENT**

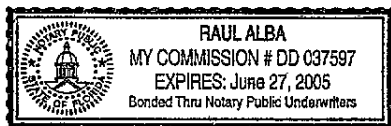

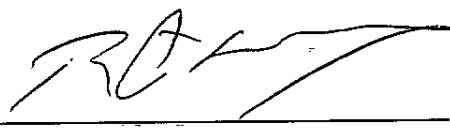
