**ARTICLES OF INCORPORATION  
OF  
THE SCRAPPY STAMPER, INC.**

The undersigned, for the purpose of forming a for profit corporation under Florida Statutes Chapter 607, do hereby make and adopt the following Articles of Incorporation:

**ARTICLE I**

**NAME**

The name of the corporation is: THE SCRAPPY STAMPER, INC.

**ARTICLE II**

**PURPOSES**

The Corporation is organized for the purposes of transacting any or all lawful business for which corporations may be organized under the laws of the United States and the laws of the State of Florida..

**ARTICLE III**

**CAPITAL STOCK**

The Corporation is authorized to issue 100 shares of U.S. \$.01 par value common stock. The Board of Directors may authorize the issuance of such stock to such persons upon such terms and for such consideration in cash, property or services, as the Board of Directors may determine and as may be allowed by law. **INDEMNIFICATION**

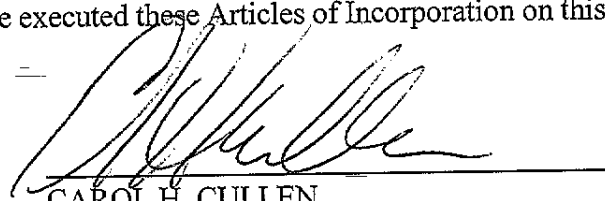
The Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent permitted by law in existence either now or hereafter.
