ARTICLE I. NAME

The name of the Corporation shall be:

REYES EXPRESS DELIVERY, INC.

The principal place of business of this Corporation shall be: 706 W. Lake Ave., Wimauma, FL 33598.

ARTICLE II. NATURE OF BUSINESS

This Corporation may engage in, or transact, any or all lawful activities or business permitted under the Laws of the United States, the State of Florida, or any other State, Country, Territory or Nation. The specific purpose of this Corporation shall be delivery and related services.

ARTICLE III. CAPITAL STOCK

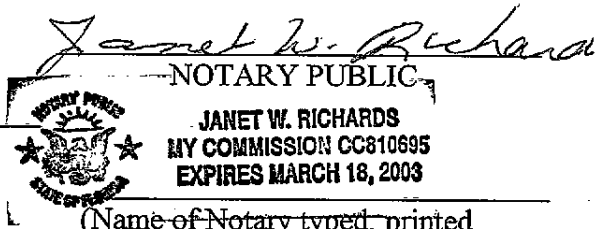
