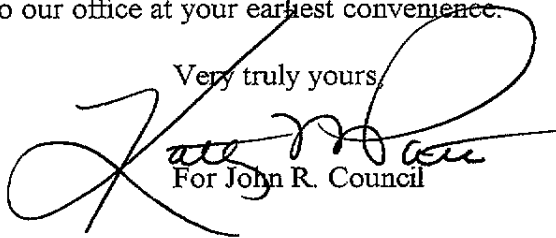

ARTICLE I. CORPORATE NAME

The name of the corporation is: Dollar For Dollar, Inc.

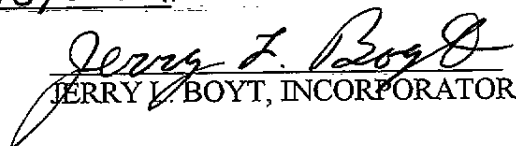

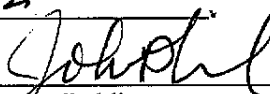
