ARTICLES OF INCORPORATION OF

The undersigned, desiring to organize a Corporation under Chapter 607, Florida Statutes set forth the following:

ARTICLE I

The name of this Corporation shall be: <u>DEVIN WAHL LATHING, INC.</u>

ARTICLE II

The duration of the Corporation shall be perpetual.
