**ARTICLE I**

Elder Masonry, Inc.

**ARTICLE II**

This corporation shall have perpetual existence.

**ARTICLE III**

The general nature of the business and objects and purposes to be transacted, promoted, or carried on are to do any and all of the things hereinafter mentioned as fully and to the same extent as natural persons might or could do viz:

- A. To purchase or otherwise acquire, hold, and deal in real and personal property and any interest therein; and to establish and carry on any business which may seem calculated to enhance the value of the property or rights of the corporation, or to facilitate the disposition there of.
- B. To do all things and everything necessary, suitable, convenient, or proper for the accomplishment of any of the purposes or the attainment of any or all of the objects herein enumerated or incidental to the powers herein named, which shall at any time appear a conducive or expedient for the protection or benefit of the corporation, either as holders of or interested in any property or otherwise, with all the powers now or hereafter conferred by the laws of the State of Florida upon corporation
- C. To contract debts and borrow money, sue and sell pledge bonds, debentures, notes and other evidence of indebtedness and execute such mortgages, transfer of corporate property or other instruments to secure payment of corporate indebtedness as required.

**ARTICLE IV**

This corporation is authorized to issue **Five Hundred (500) shares of One (\$1.00) Dollar per value common stock.**

**ARTICLE V**

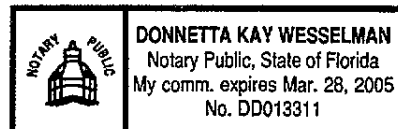
