ARTICLE INAME

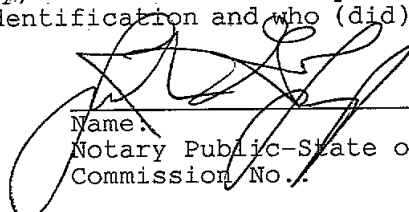
