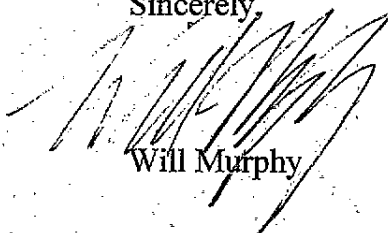

**Article I: CORPORATE NAME**

The name of this corporation is OUTDOOR ADVENTURE GEAR, INC.

**Article II: NATURE OF BUSINESS AND POWERS**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida, including the purchase and operation of other business entities, and including but not necessarily limited to retail sales of outdoor recreation products.

**Article III: CAPITAL STOCK**

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 5000 shares of \$1.00 par value common stock.

**Article IV: TERM OF EXISTENCE**

This corporation shall have perpetual existence, unless otherwise required by law.

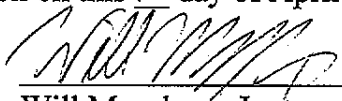

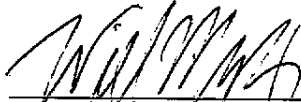
