Notice of non - reporting

We have received the notice of Non-Reporting and from the D.O. S. Division of Corporations. The original U.B.R. was remitted in a timely manner on February 20th, 2003.

On December 28, 2002, we sent request detailing changes to the Corporation (copy enclosed), which was received and answered on December 31, 2002 (copy enclosed). Following the instructions on that letter, we downloaded the form from the online service, as we did not receive a UBR form and sent it in on February 20, 2003, with our check no. 1124 for \$ 150.00.
