The undersigned, acting as Incorporator of a Florida corporation ("Corporation") and under Florida Business Corporation Act, Chapter 607 of the Florida Statutes, and other laws of the State of Florida, hereby causes to be delivered the following Articles of Incorporation for such Corporation:

**ARTICLE ONE**

NAME: The name of the Corporation is BOW WOW & MEOW PET SITTING, INC.

**ARTICLE TWO**

ADDRESS: The street and mailing address of the Corporation is: 8612 Bunting Road, Tallahassee, FL 32305.

**ARTICLE THREE**

COMMENCEMENT OF CORPORATE EXISTENCE: The Corporation shall begin on the date these Articles of Incorporation are filed with the Department of State.

**ARTICLE FOUR**

PURPOSE: The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

**ARTICLE FIVE**

CAPITAL STOCK: The Corporation is authorized to issue One Hundred Shares (100) of Common Stock having a par value of One Dollar (\$1.00) per share.

**ARTICLE SIX**


