
ARTICLE VII



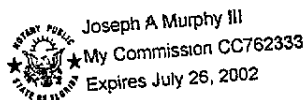


