

The undersigned subscriber to these Articles of Incorporation hereby forms a corporation under the Florida General Corporation Act.

**ARTICLE I**  
**Name of the Corporation**

The name of this corporation is Sacred Medical Supply, Inc.

**ARTICLE II**  
**General Purpose**


